#### PROCESS FOR OBTAINING STATUTORY CERTIFICATE OF OCCUPANCY IN ABIA STATE

In Abia State, Statutory Certificates of Occupancy can be obtained through one of two ways namely Land Use and Allocation Committee (LUAC) or any of the Zonal Land Offices at Umuahia and Aba.
