#### **ACCOUNTING POLICIES**

In line with the adoption of the IPSAS in Nigeria, a NCOA and standardized format of GPFS have been designed and introduced for adoption by all tiers of Government in Nigeria. Consequently, some notable accounting policies were employed in preparing and presenting the attached financial statements. The accounting policies employed are in accordance to New Model Financial Memoranda For Local Governments in Nigeria 1992, and as amended in 2009. The policies are also in compliance to International Public Sector Accounting Standards. They include:

#### 1. Basis of Preparation

The GPFS shall be prepared under the historical cost convention and in accordance with IPSAS and other applicable standards as may be defined by relevant statutes. IPSAS Cash basis accounting method was adopted in the preparation of the financial statements. Under this method, Income and Expenditure are recognized as at when received and paid respectively.

#### 3. Accounting Period

The accounting year (fiscal year) shall be from 1<sup>st</sup> January to 31<sup>st</sup> December in line with the National Treasury Circular Ref. **OAGF/CAD/026/V.1/102 of 30<sup>th</sup> December, 2013.** Each accounting year is divided into 12 calendar months (periods) and shall be set up as such in the accounting system.

#### 4. Reporting Currency

The GPFS shall be prepared in the Nigerian Naira

#### 7. Notes to the GPFS

Notes to the GPFS shall be presented in a systematic manner. The Items in the Statements should cross reference to any related information in the Notes and the financial statements. It shall follow the format provided in the Accounting Manual.

The Accounts of **Bende Local Government** for the year ended December 31, 2019, have been examined by me as provided in Chapter 5 of Abia State Local Government Law No. 2 of 2006, in accordance with New Model Financial Memoranda For Local Governments, 2009; and also in compliance to International Public Sector Auditing Standards; and other extant financial Regulatory Authorities. #### STATEMENT OF FINANCIAL PERFORMANCE FOR THE YEAR ENDED DECEMBER 31, 2019

#### **REVENUE**

5. Total for the accrued revenue vear amounted to ₩2,377,434,715.17 .Over 66.77% of this amount, that is, ₩1,587,466,595.20 was realized as statutory revenue from Federal Accounts Allocation Committee (FAAC). A sum of ₹430,148,063.45 was realized as Value Added Tax (VAT) which represent 18.09%. A sum of N218,823,529.41 represent the amount of money accrued from bank facilities which is 9.20%. The sum of N8,237,125.00 was internally generated, this amount constituted about 0.35% of the accrued revenue. The remaining 5.58% was Transfer from Consolidated Revenue Fund, which amounted to ₩132,759,402.11.

#### **EXPENDITURE**

6. Total expenditure incurred during the year amounted to ₦2,287,387,214.40. This comprises ₦617,643,732.88 for Salary; ₦98,083,552.92 for Over Head; and ₦1,571,659,928.60 being Grants and Contributions.

#### **ASSETS**

7. During the year, the Local Government acquired no non-current assets on Property, Plant and Equipment.
