ACCOUNTING POLICIES

In line with the adoption of the IPSAS in Nigeria, a NCOA and standardized format of GPFS have been designed and introduced for adoption by all tiers of Government in Nigeria. Consequently, some notable accounting policies were employed in preparing and presenting the attached financial statements. The accounting policies employed are in accordance to New Model Financial Memoranda For Local Governments in Nigeria,1992, and as amended in 2009. The policies are also in compliance to International Public Sector Accounting Standards. They include:

1. **Basis of Preparation**

The GPFS shall be prepared under the historical cost convention and in accordance with IPSAS and other applicable standards as may be defined by relevant statutes. IPSAS Cash basis accounting method was adopted in the preparation of the financial statements. Under this method, Income and Expenditure are recognized as at when received and paid respectively.

3. Accounting Period

The accounting year (fiscal year) shall be from 1st January to 31st December in line with the National Treasury Circular Ref. **OAGF/CAD/026/V.1/102 of 30th December, 2013.** Each accounting year is divided into 12 calendar months (periods) and shall be set up as such in the accounting system.

4. Reporting Currency

The GPFS shall be prepared in the Nigerian Naira

7. Notes to the GPFS

Notes to the GPFS shall be presented in a systematic manner. The Items in the Statements should cross reference to any related information in the Notes and the financial statements. It shall follow the format provided in the Accounting Manual.

The Accounts of **Ukwa East Local Government** for the year ended December 31, 2018, have been examined by me as provided in Chapter 5 of Abia State Local Government Law No. 2 of 2006, in accordance with New Model Financial Memoranda For Local Governments, 2009; and also in compliance to International Public Sector Auditing Standards; and other extant financial Regulatory Authorities. And I hereby certify that the accounts were prepared on the basis of International Public Sector Accounting Standards pertaining to Local Government systems; subject to observations made in both Audit Inspection Report thereof, and this report thereto.

2. The Cash Assets as at December 31, 2018, amounted to \$138,796,614.53This figure includes Cash and Cash Equivalents of \$132,758,114.53, and the outstanding Receivables of \$6,038,500

3. The Cash liabilities as at December 31, 2018, amounted to N2,505,821.05

NET ASSETS/EQUITIES

4. Matching liabilities against the assets results in net assets/equities. As at December 31, 2018, the accumulated Reserves stood at ₦136,290,793.48

STATEMENT OF FINANCIAL PERFORMANCE FOR THE YEAR ENDED DECEMBER 31, 2018

REVENUE

5. Total accrued revenue for the year amounted to ₩1,635,281,832.29. Over 66.28% of this amount, that is, ₩1,103,544,079.27 was realized as statutory revenue from Federal Accounts Allocation Committee (FAAC). A sum of ₩7,616,223.88 was internally generated. This amount constituted about 0.46% of the total accrued revenue. The sum of N250,972,389.91 represent Value Added Tax, this amount constituted 15.08%, and Other Capital Receipt of N264,705,882.35 represent 15.89%. The remaining 2.29% was Transfer from Consolidated Revenue Fund, which amounted to ₩8,443,256.88.

EXPENDITURE

6. Total expenditure incurred during the year amounted to ₦1,487,181,038.81. This comprises ₦373,407,480.61 for Salary; ₦ 75,230,812.34 for Over Head; and ₦1,028,542,745.86 being Transfer payments.

ASSETS

7. During the year, the Local Government acquired non-current assets on Property, Plant and Equipment of \$11,810,000.00.

SURPLUS/ (DEFICIT)

8. Surplus/(Deficit) from Operating Activities for the year amounted to ₦136,290,793.48

9. The total net cash in/(out) flows arising from the year's operating, investing and financing activities amounted to \$124,314,857.65.

10. The current year total net Cash Flows from all Activities in cash and cash equivalents of \$124,314,857.65 added to cash and cash equivalents of N8,443,256.88 at the beginning; and the amount for Certificate of Deposits, summed up to \$132,758,114.53 being Cash and cash Equivalents at the end.

11. The Cash and Cash Equivalents at the end are in agreement to the Closing Cash Balances and Certificates of Deposits. Vide Note 26 for details.
