Long Title

A Law to make provision for the appropriation of the sum of One Hundred and Forty-Seven Billion, Two Hundred and Eighty Two Million, One Hundred and Ninety Six Thousand, Two Hundred Naira (N147,282,196,200) only for the services of the Government of Abia State of Nigeria for the year ending 31st December, 2022 and for other related purposes.

Enactment:

BE IT ENACTED BY the House of Assembly of Abia State of Nigeria as follows:

Part I: Preliminaries

Citation and Commencement

 This Law may be cited as the Abia State of Nigeria 2022 Appropriation Law and shall be deemed to have come into force on the1st day of January, 2022.

Interpretation

In this Law except the context otherwise requires:
 "Accountant-General", means Accountant-General of Abia State;

"Governor", means Governor of Abia State;

"State" means Abia State of Nigeria.

No issue after 31st December, 2022

Issue of N67,502,318,700

The Accountant-General shall when authorized to do so by warrants signed by the Governor, pay out of the Consolidated Fund of the State, the sums not exceeding in aggregate the sum of Sixty-Seven Billion, Five Hundred and Two Million, Three Hundred and Eighteen Thousand, Seven Hundred Naira (N67,502,318,700) only.

Appropriation of **N**67,502,318,700

4. The sum mentioned in section 3 shall be appropriated to the Heads of Expenditures as indicated in the First Schedule to this Law.

Transfer from the Consolidated Revenue Fund to Capital Development Fund of N79,779,877,500

5. The Accountant –General shall when authorized to do so by the Governor transfer from the Consolidated Revenue Fund to the Capital Development Fund, the sums not exceeding in aggregate, the sum of Seventy Nine Billion, Seven Hundred and Seventy Nine Million, Eight Hundred and Seventy-Seven Thousand, Five Hundred Naira (N79,779,877,500) only.

Expenditure of N79,779,877,500

6. The Accountant-General shall, when authorized to do so by Warrants signed by the Governor, pay from the Capital Development Fund, the sums not exceeding in the aggregate, the sum of Seventy Nine Billion, Seven Hundred and Seventy Nine Million, Eight Hundred and Seventy-Seven Thousand, Five Hundred Naira (N79,779,877,500) only.

Appropriation of ₩79,779,877,500

7. The Sums mentioned in section 6 shall be appropriated to the Heads of Expenditure mentioned in the Second Schedule to this Law

No Issue after 31st December, 2022.

8. No part of the sums in sections 3 and 6 of this Law shall be issued out of the Consolidated Revenue Fund or Capital Development Fund of the State after 31st December, 2022.
