1 Summary of Performance

1.A Introduction

This Budget Performance Report for Abia State is prepared quarterly and issued within 4 weeks from the end of each quarter.

The 2023 Budget:

Theme: "Valedictory, Economic Expansion and Stability Budget".

The 2023 Budget is designed to focus on the successful completion of on-going programmes and projects that have direct bearing on the people's wellbeing. This will enable the Government to consolidate the gains of the past years in the provision of social amenities for the people. We also see this as an opportunity to pursue recovery by redirecting resources to improve on the production chain in the State and add value to products from our people. It is an opportunity to complement established suppliers and producers with cost-effective, quality products from our people.

The State adopted 2023-2025 Medium Term Expenditure Framework and Fiscal strategy paper of the Federal Government which set the parameters for the 2023 Budget as follows:

- Benchmark oil price of \$70.0 per barrel;
- Daily Oil Production of 1.69 million barrels;
- Exchange rate of N435.57 per US Dollar;
- Projected GDP growth rate of 3.75%; and
- Inflation rate of 17.16%

Prioritizing stability, in our view, will create confidence, which in turn will encourage investment. We prepare this budget as a complement and a necessary signal for the private sector to increase investment in the production and supply chains of the State's economy.

Intended Measures

The following measures will be taken by the Government in the pursuit of its intentions under the 2023 fiscal year:

- Foster the security of lives and property by targeting the roots of communal violence, crime and other potential sources of insecurity.
- Continue to promote good governance founded on competent and responsive public service with zero tolerance for corruption.
- Build, maintain, and expand infrastructure in water, electricity and road networks to accelerate economic growth and create jobs.
- Promote agriculture and food security through greater access to inputs and rural access roads.
 Support emphasis on agriculture as a source of wealth creation and capital formation in its own right.
- Continue to engage Ease of Doing Business platforms to support trade and investment, industry and SMEs, remove obstacles to investment and help operators in Abia business environment to find and exploit opportunities.
- Ensure completion and commissioning of Automated Garment Factory and other clusters.
- Remodeling of key markets in Aba like Ariaria International Market and New Market.

This report includes the approved budget appropriation for the year 2023 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Q1 report is assessed against the 2023 Original budget.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23 / 32
- Others Economic Account Classes 2203-2209 as applicable

This Budget Performance Report is produced by the Abia State Planning Commission, Budget Department/Office of the Accountant General, Accounts Production Department and published on the Abia State website.

1.B Revenue Performance

As at first quarter the aggregate revenue inflow from both FAAC and State is **N24,216,654,550.04** which represents **23.1% Performance Year to Date (Q1)** of the **N 104,797,764,400.00** total Approved revenue estimates .

The break-down of the total revenue inflow is as follows:

- Government Share of FAAC (Statutory Revenue) -=N19,175,036,946.61 which is (26.0%) of the estimated Statutory Allocation of N73.874,663,700. This is the gross statutory allocation for the first quarter.
- 2. Independent Revenue= N5,041,617,603.63 which is (16.3%) of N30,923,100,700 being projected Independent Revenue.
- 3. Capital Receipts- There was a Capital Receipt inflow of **N1,539,702,053.53** at the point of reporting which **(2.8%)** of **N55,719,739,900** approved Capital Receipts estimates .

1.C Recurrent Expenditure Performance

The first Quarter total Recurrent Expenditure is **N8,269,956,714** which is (10.9%) of **N75,778,628,100** approved Recurrent Expenditure Estimates: The breakdown is as follows:

Personnel Cost: N6,498,154,361.30
 Over Head Cost: N301,009,786.64
 Other Recurrent Cost: N1,470,792,066.06
 Total Recurrent: N8,269,956,714

1.D Capital Expenditure Performance

The total capital expenditure captured in the first quarter is **N3,307,659,425.86** which is **(3.9%) of N84,738,876,200** approved capital expenditure. This is low due to delay of submission of expenditure data from Project implementing Ministries and Agencies as at the point of reporting.

1.E Conclusions

In the first quarter report, Abia State 2023 Performance Year to Date Revenue excluding opening Balance is **N25,756,357,203.55** which is **14.9%** performance. The actual closing balance after publication of the year 2022 final account will be captured as opening balance in the second quarter report.

On the Expenditure, a total of N11,577,615,639.86 (9.2%) was expended from N160,517,504,300 of the total approved Budget expenditure for first quarter. It is expected that more returns from the Ministry, Department and agencies would be captured in the second quarter and supplementary provisions for agencies that overspent on some of the approved economic line items.
