

AN EXECUTIVE ORDER FOR THE REVIEW OF RATES AND TARIFFS OF REVENUE COLLECTION BY THE ABIA STATE ENVIRONMENTAL PROTECTION AGENCIES

Instrument (No 3)

In exercise of the powers conferred by Section 2 of Abia State Tax Codification and Consolidation (Amendment) Law of 2024 and all other Constitutional powers enabling me in that behalf, I Dr Alex Chioma Otti, OFR, the Governor of Abia State of Nigeria, hereby make the following orders:

- Commencement: The rates and tariffs shall become effective on the 1st of January 2025.
- Citation: This Executive Order may be cited as the ASEPA rate and tariffs review of 2024.
